BRAGS - BRAGS

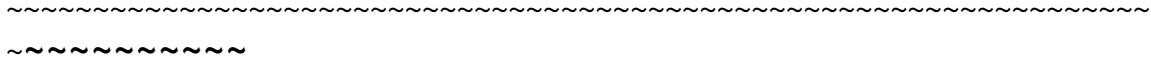

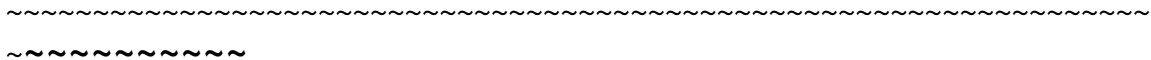
